President's Report

Summer came early and then disappeared, but hopefully is now back for good.

There are three special dates to remember: July 21st - Annual meeting at Keuka College Library (8:30AM coffee, 9:00 – 11:00 meeting)

July 28th – First "Annual" Pot luck Party

July 31st – Conservation/Social Gathering 6:30 pm - informal meeting of those interested in more info on the FLLT (see Conservation News).

We have had several changes to our Board this year and will be electing five new board members at the annual meeting. As you may recall Joyce Herbert and Rob Plummer retired from the Board after our last annual meeting. Charlotte Wytias moved to Colorado and Bruce Turner had a number of new commitments. These folks spent lots of time helping to achieve the goals of the BPA and I really appreciate all their help.

Your board has nominated Ray Copson, Martha Johnstone, Bob Morse, Tom Williams and Lynn Wuytowicz to fill our vacancies. Continuing on the board will be Scott Demmin, Lisa Saether and Tom Close. After 3 years as president, I will become the Past President, an unofficial board member.

Again this year, we have a full agenda for our annual meeting.

Routine Business Meeting – Approve minutes, receive Treasurer's report and election of directors and officers.

Local Update – Very quick update on local issues – budgets, taxes, hydrofracking etc.

Finger Lakes Land Trust – David Diaz and Elizabeth Newbold will present additional information about the partnership between your BPA and the FLLT. A short summary elsewhere in the newsletter indicates we are off to a great start.

Penn Yan Central School District - David

Hamilton, Superintendent, has agreed to give an update as to what has happened over the last year and where we are headed in the school system. I was especially pleased with work that the District and public did on this year's budget. Significant reductions in funding and increases in benefit costs made this year pretty tough to get the numbers worked out.

Keuka College – We are working with the college to have a senior representative give us a report on the college. They are our partners on the Bluff and we have not had a report since I have been active with the BPA. July is a tough time for them as their commitment to the Asian program is most active in the summer.

Finger Lakes Museum – President, John Adamski and new Development Director, Richard Lane will make a presentation on what has been accomplished, implementation of the "Branchport Campus", and near term expectations.

BPA Program – We will have an open discussion on two significant programs within our group.

First: We would like to form several committees to spread the load and make the BPA more effective. We have not done as well as we should in auditing local committee and board meetings. We have also missed a few opportunities to involve the Bluff in community events (for instance we should have been organized to help with the TOJ clean-up day, June 16). We are considering implantation of a blog on our website to keep everyone informed of activities that affect us on the Bluff. All this will take active involvement of our members.

Second: We are planning to discuss the organization of the BPA. As you know we are not a 501(c)3 organization. Recent changes to the tax laws indicate that we may need (or want) to open the membership to include everyone on the Bluff and change the "dues" structure to meet current regulations. Two other local organizations have changed their structure to comply with these new rules. I hope to see you all at the annual meeting. I think it will be another successful event.

Organizational Meeting

Following our July 21st Annual meeting, the BPA Board will hold an organizational meeting to formalize our working committees for the organization. Potential committees include:

Conservation Committee

Their role is to coordinate all conservation efforts as they are related to Bluff Point. Coordination between the newly formed partnership with Finger Lakes Land Trust being a primary focus. This would include educational, fund raising and helping those who are considering easements.

Audit Committees

It seems to be a general consensus that reporting on status of Town Government, local school issues and other relevant local topics is most appreciated. To this end, we propose to form committees to audit the following:

- 3. Penn Yan Central School District Board Meetings
- 4. Recreation/Activities (Keuka College, Museum, etc.)

To convey the information gathered, we need a communications committee that would coordinate newsletter efforts, optional email announcements and potential enhancements to our web site (see To Blog below).

The important message here is that we need your help. Your involvement will help all of us stay abreast of the issues that effect our area and active participation will assure that our (your) influence will help determine the direction that our precious Bluff will take.
